## Information for customers on use of their data and their rights

Dear Customer, in accordance with Art. 13 of the General Data Protection Regulation (EU) 679/2016 (hereinafter the "Regulation"), we inform you that, in order to provide you with insurance products and/or services requested by or envisaged for you we need to collect and use certain data relating to you.

## WHAT DATA DO WE COLLECT?

We process personal data (such as your name, surname, address, date and place of birth, profession, etc.) necessary to provide you with a quote requested by you, if personalised.

In the event of your refusal to provide us with certain of your personal data we may provide you with an anonymous quote.

## HOW WE TREAT YOUR DATA

For the purposes indicated above, your data will not be disclosed to others and will be processed by employing appropriate means and procedures, including IT and computerised systems, and may become known solely to persons duly authorised by the Company to provide you with personalised quotes requested by you and for related regulatory compliance (required by ISVAP Regulation 23/2008).

Your personal data may be acquired and used by other Unipol Group companies<sup>(1)</sup> and communicated to IT or technical or organisational service providers, as well as to reinsurance companies, in Italy and abroad, to allow SIAT Compagnia di Assicurazioni e Riassicurazioni S.p.A. to arrange reinsurance cover and to other insurance companies for the transfer of coinsurance shares.

Your personal data will be stored in full accordance with the security measures laid down by personal data protection regulations for twelve months subsequent to the period of validity of the quote, after which they will be deleted.

## WHAT ARE YOUR RIGHTS?

Privacy legislation (arts. 15-22 of the General Data Protection Regulation (EU) 679/2016) grants you the right to access your data at any time, as well as to request rectification of or additions to the data, if inexact or incomplete, erasure of the data or restriction of processing thereof, if there are valid reasons for doing so, or to object to the processing thereof for reasons attributable to your specific situation, as well as the right to data portability, where the data has been processed by an automated system for the provision of the contractual services requested by you, within the limits of the provisions of the Regulation (art. 20).

The foregoing is without prejudice to your right to submit a complaint to the Italian Data Protection Authority (Italy's data privacy watchdog), where deemed necessary for the protection of your personal data and your rights in relation thereto.
